*The application fee will only be charged once to students taking from 1 to 4 levels or pathway programs.

**Intensive Academic English- Level 4 (IAE4) is considered a Pathway Program designed for students who do not meet their English Proficiency Level (ELP) admission requirement for direct entry to our post-secondary programs. Successful completion of the IAE4 program, with a minimum passing grade of 80%, will fulfill the ELP admission requirement.

2. PAYMENT POLICY

Intensive Academic English

- For Intensive Academic English, full tuition and fees must be paid 4 weeks prior to the start of the program.
- Application fee of \$225 is non-refundable

Post-secondary programs

- Full tuition fees or a minimum of \$15,000 including the seat deposit must be paid by the specified payment deadline (usually at least 8 weeks prior to the program start date)- Please refer to the [Payment Schedule](#).
- The application fee of \$225 and the \$2,800 seat deposit are **non-refundable** and **non-transferrable**.
- If a minimum of \$15,000 is not paid by the due date set by Robertson, the seat will be cancelled and submission of a new application will be required for the next available intake.
- For late admissions, the initial payment of \$15,000 is treated as the seat deposit. To receive a letter of acceptance, the full tuition fee or the initial payment must be submitted by the given deadline.
- Payments not received by the due date may incur additional fees or affect your enrollment in the program.
- **No deferral requests will be granted** other than [visa refusal](#). The official refusal from IRCC must be provided to Robertson College to receive a deferral.

Refund Policy for Robertson Programs (MLA)

Refunds will be made only in the same manner of which it was paid. In order for a student contract to be terminated, the following must occur:

- A. The student gives written notice of withdrawal or,
- B. The student is expelled from the program due to a violation of college policy, or
- C. The student is absent for more than 10% of the total hours of instruction within the first 2/3 of the program.

Prior to start of the Program	Full refund minus non-refundable fees
After start of the program	Full refund minus non-refundable fees and the amount determined in accordance with the Private Vocational Institutions Regulation . A refund calculation will be sent to the student using the <i>Refund Calculator</i> provided by the Manitoba Regulation and Accountability Office which determines the refund amount the student is eligible for.
2/3 after start of the program	No refund (If there is a balance due, the student is responsible for making payment arrangements)

Visa Refusal

Applicants who are denied a Study Permit will forfeit only the application fee. A copy of the visa rejection letter from Immigration, Refugees, and Citizenship Canada (IRCC) is required to process the deposit and tuition refunds.

Please note, the refund process takes up to 6 weeks from the date we receive the full withdrawal package.

** Proof of visa rejection must be submitted within 4 weeks from the date of rejection.*

Study Permit must be submitted at least one month before the program start date. If the study permit application has not been approved by IRCC before the deadline, the one-time exception on the No Deferral Policy will apply.
